I accept and assume all risk and dangers and all responsibility for any such accident or injury no matter how, or by whom, it may be caused. Release, Waiver, Hold-Harmless and Indemnity. To the fullest extent permissible by law, I hereby release, waive, discharge and covenant not to sue the Club, or the landowners. From all liability, and agree to indemnify and hold them harmless for accident or injury whether caused by the negligence of the Club, and the landowners, or otherwise. I have read this assumption of risk, release and waiver of liability, hold-harmless and indemnity agreement, fully understand its terms, understand that I may have given up substantial rights by signing it, and have signed it, on behalf of myself and my children, freely and voluntarily without any inducement, assurance or guarantee being made to me and fully intend my signature to be a complete, continuing and unconditional release of all liability to the fullest extent allowed by law.</p>

<p>I recognize that people will judge all motorized trail users by my actions. I will ride only on designated signed or mapped trails and areas. I will slow down, use caution and be courteous when I encounter other trail users. I will respect and preserve public and private property that I ride on. I will ensure my equipment meets New York State safety, insurance and emissions. I will not ride beyond my ability or while being impaired by drugs or alcohol. I will not attempt to disturb or directly pursue wildlife in my recreational vehicle. I will not construct jumps or obstacles anywhere on the trail or riding areas. Failure to abide by the code of ethics may be just cause for termination by vote of the board of directors.</p>
